

## Reëls vir die bedryf van n stalletjie by die Pretoria Boeremark

### Toelating

- Landbouprodukte of kos of handgemaakte kuns artikels word toegelaat.
- Slegs een van die kategorieë word per stalletjie toegelaat.
- U moet eers na die terrein kom kyk en uself vergewis van beskikbare stalletjies – daarvoor kan u tussen 8.00 en 8.30 op n Saterdag oggend by die houthuisie vir of Johan of vir Ute van Wyk vra.
- Die Pretoria Boeremark behou homself die reg voor om van tyd tot n moratorium op sekere produkte te plaas al val die produk in die vereiste kategorie.

### Stalletjie fooie

- Eerste Saterdag se koste is R540 (Intree fooi van R400 + stalletjie R140)
- Hierdie geld is nie terugbetaalbaar nie.
- Wanneer u besluit het om te kom nadat u n stalletjie gekies het, moet die vorm voltooid en n bewys van betaling die eerste Saterdag saamgebring word.
- Een stalletjie se koste is R140 per Saterdag, twee stalletjies is R280 per Saterdag en drie stalletjies is R350 per Saterdag.
- Stalletjie fooie sal met R20 per Saterdag op 1 Oktober verhoog.

### Stalletjies

- Bring u eie tafels, stoele en gazebo ens. vir u stalletjie. Daar is nie skaduwee nie.
- U moet u staanplek opruim en skoon agterlaat.
- Geen stalletjies mag gedeel word nie.
- Geen stalletjies mag skuif sonder die toestemming van die mark bestuurder nie.
- Slegs produkte waarvoor u geregistreer het mag verkoop word.
- Geen elektrisiteit is op die stadium beskikbaar nie.
- U moet aan die wetsvereistes m.b.t. u produk, asook die werksaamhede by u stalletjie voldoen bv. indien u met gas kook die nodige brandbestryding items by u stalletjie hê.

## Rules for running a stall at the Pretoria Boeremark

### Admission

- Agricultural products or food or hand made crafts are allowed.
- Only one of the categories is allowed per stall.
- You must first come to have look at available stalls - you can then meet us at the Wendy between 8:00 and 8.30 on a Saturday morning and we will let you know whether the stand is available.
- The Pretoria Boeremark reserves the right to place a moratorium on certain products from time to time even if the product falls into the required category.

### Stall fees

- First Saturday's cost is R540 (Entry fee of R400 + stall R140)
- This amount is not refundable.
- If you decide to come after selecting a stall, please bring completed form and proof of payment along.
- One stall costs R140 per Saturday, two stalls R280 per Saturday and three stalls R 350 per Saturday.
- Stall fees will go up with R20 per Saturday on 1 October 2017.
- Stall fees are payable in advance:

- Weekly payments must be reflected in the bank account before Saturday.

### Vehicles

- No vehicles may move between 5:30 and 9:30 on the market. You will lose your stand if you do not obey this rule.
- No vehicles may park on the premises except in areas where vehicles are allowed. You will be notified accordingly.

### Stalls

- Bring your own tables, chairs and gazebo etc. for your stall. There is no shade yet.
- You must leave your stand as you found it.
- No stalls may be shared.
- No stalls may move without the permission of the market manager.
- Only products for which you have registered may be sold.
- No electricity is available at this stage.
- You must comply with the legal requirements regarding your product at your stall, eg. If you cook with gas the necessary fire fighting items have to be present at your stall.
